TERMS OF PARTICIPATION AND LIABILITY EXCLUSION

- The climbing course is known as a risky activity and takes place at one's own risk. The instructions of the staff are to be followed at all times, esp. instructions given during the safety briefing at the beginning of the experience. Participants shall never be unsecured on climbing elements or trees. Despite the operator's best efforts, staying in the forest always entails a certain residual risk.
- The participant confirms that he/she is at least 14 years of age (18 if signing as responsible for children under 14). Persons under 18 confirm that they are acting with the consent of a parent or legal guardian.
- This activity requires bodily and mental fitness. If any doubt exists, we recommend visiting the climbing courses from the ground and asking for medical advice. In any case pregnancy, serious back problems and cardiac arrhythmia prohibit participation. Body mass up to 130 kg; Banana jump up to 110 kg; giant flying fox (Bad Neuenahr only) up to 100kg.
- No participation under the influence of drugs or alcohol. Items that may be dangerous while climbing (e.g. items that could fall) are prohibited on the climbing course. Jewelry (incl. piercings) poses a risk of injury. The operator strongly advises removing jewelry. Participants climbing with jewelry do so at their own risk; the operator is not liable.
- Any accident must be brought immediately to the attention of surveillance personnel, an accident report must be filed.
- The personal safety equipment (PSE) must be checked by personnel after being put on, before climbing. Access to children's courses only under staff supervision. In the Adventure courses:
 - parks Leiwen and Velbert: safety connector is a rigid hook. Before leaving the ground, the steel hook must be passed in the lifeline and the fall-stop carabiner must be connected to the harness;
 - park Bad Neuenahr: two carabiners as safety connector. Before leaving the ground, both carabiners must be connected to the yellow link on the fallstop rope.
- Before starting on a flying fox, participants must visually check that the line and landing area are free. Before climbing into any course, the degree of difficulty (green: easy; blue: medium; red: difficult; black: very difficult) must be taken into consideration in relation with one's own capability and fitness.
- Participants who violate the safety rules or fail to comply with the staff's instructions will be excluded from the climbing course. The entrance fee might not be refunded. In such cases, the liability of the participant may be engaged.

ADDITIONAL PROVISIONS FOR MAJORS ACCOMPANYING CLIMBING GUESTS UNDER 14 YEARS

- I am legal guardian of the minors listed at the back of this sheet, or am acting in agreement with their legal guardian. I want them to use the climbing course „Wald Abenteuer“. I will ensure that they abide at all times by the rules set forth in this document.
- Participants may enter the children's courses only upon instruction by the staff.
- I will be at all times in little distance from the children, so that they can at any time call me and communicate with me.
